Art Submission

PLEASE READ CAREFULLY:

- 1) Complete the Entry Form and submit with your artwork.
- 2) Contestants' name and age MUST be written carefully on the back side of the artwork. *This step is important, as your entry form and mailing envelope will be separated from your artwork.*
- 3) Your Entry Form should NOT be attached to the artwork. No tape, no staples, no glue, no paper clips!
- 4) Mail-in entries will NOT be returned to the contestant: MONUMENT VALLEY BALLOON EVENT plans to display the artwork at the ARTSCO, Inc. establishment and will be used as a promotional item.
- 5) Give your artwork a creative title.
- 6) Note that Mail-in entries can be any size you wish, and created using any materials.
- 7) We strongly advise inserting a sturdy piece of cardboard into the package to keep it from getting bent. Write DO NOT BEND on the outside of your package, front and back, with large writing.

- 1) Submitted artwork must be your original creation.
- 2) No tracing of others' artwork.
- 3) The MONUMENT BALLOON EVENT Art Contest ends on December 4, 2015. All entries must be received no later than December 4, 2015.
- 4) Entries must be submitted using the guidelines stated
- 5) All contestants will be required to agree to the Art Contest Terms & Conditions in order to enter.

6) Art Theme – Native American Culture and Tradition

- 7) All contestants must register for this contest by entering their name, email, age, name of school and mailing address, and agreeing to the terms and conditions of the contest.
- 8) The Art Contest will be judged by a panel of judges appointed by ARTSCO, INC.

 - ***Note: 1st, 2nd and 3rd Prize will be awarded in each Grade Level: K-12**
